在助人的工作中,以至在我們的人生中,我們感受和經歷種種的苦難。有一刻,我們累了,也許就是時候停 下來,重新反思是什麼在艱難中叫我們繼續走下去.....

或許,一本好書能讓我們開始這次的探索。講者WALLACE將帶領參加者進入認識苦難意義的旅程,並期望與 大家深入了解意義治療(LOGOTHERAPY)的創始人VIKTOR FRANKL最著名作品 — MAN'S SEARCH FOR MEANING,一起認 識意義治療,一起尋找在苦難中的意義。

MAN'S SEARCH FOR MEANING 一書包括三部份: 1) VITKOR FRANKL 在集中營中的經歷; 2) 意義治療的簡介; 3) 對LOGOTHERAPY 中TRAGIC OPTIMISM 這概念的闡述。首先我們將認識FRANKL 在集中營中的苦難,從而理解及 反思人如何能在絕境中,依然彰顯面對苦難的自由。在此基礎下,我們將理解意義治療的核心原則,並明白 FRANKL 如何以自身的苦難來驗證意義治療的真實。最後,我們將特別探討如何在不同的困境中,包括:痛 (PAIN)、愧疚 (GUILT)及 死亡 (DEATH),實踐真正的樂觀精神。講者將詳細講解書中的內容,並分享個人的反 思,及內容對助人專業者的幫助。對未曾閱讀此書的參加者,此課程將有助你掌握書中內容,提升你閱讀此 書的興趣,並邀請你共同反思苦難中的意義。對曾閱讀此書的參加者,此課程則有助你更深入認識意義治 療,並探索如何將書中所學,與自己的工作及人生作整合。參加者將獲得MAN'S SEARCH FOR MEANING 一書,除 作為培訓教材以外,更讓你能在日後再次細閱及收藏。
