SUPERVISEE

This workshop aims to provide opportunities for helping professionals to enhance professional competence of marital and family therapy through clinical supervision.

Participants will earn a total of 12 group supervision hours after completing this clinical supervision course from Professor Joyce Ma, who is an Approved Supervisor of AAMFT.

Content

Clinical supervision sessions include

- Supervisee's case presentation with video or role play#
- Case conceptualization
- Skill practice and drilling
- Supervision and feedback

#Each supervisee will be required to present around 20 minutes with conducting family therapy

Target Participants

Helping professionals (including social workers, psychologists, nurses, doctors, allied health professionals) with degree or above; and relevant training on family and systemic approaches.

Professor Ma Lai-chong, Joyce (Ph.D., R.S.W., Clinical Fellow and Approved Supervisor, AAMFT) Emeritus Professor, Department of Social Work, The Chinese University of Hong Kong

Professor Ma's specialties and research interests cover the areas of family therapy, multiple family therapy, and mental health with focuses on eating disorders, Attention Deficit Hyperactivity Disorder (ADHD), Autism Spectrum Disorder (ASD) and Intellectual Disabilities (ID). Professor Ma is a Clinical Fellow and an Approved Supervisor of the American Association for Marriage and Family Therapy (AAMFT). Professor Ma is the founder of the Family and Group Practice Research Center, the Department of Social Work of The Chinese University of Hong Kong. She was the president of the International Family Therapy Association (IFTA) in 2019-2021. Professor Ma has published 9 books and 121 refereed journal articles at international, regional and local venues of significant impact and visibility.

She is also recognized as the Clinical Fellow of the American Association for Marriage and Family Therapy (AAMFT). She used to be a clincial social worker in healthcare and mutli-sectoral settings.
