

Intensive Training in Child-Centered Play Therapy

Description

Child-Centered Play Therapy (CCPT) is a nondirective play therapy approach for children who have emotional and behavioral difficulties. The efficacy of CCPT for children has been well established by research over many years. This training also serves as a foundation for preparing practitioners in understanding and applying Filial Therapy to work with parents.

Learning Objectives

By the end of the training, participants will be able to:

- Describe in practical terms what is meant by each of Axline's 8 principles of CCPT
- Compare and contrast the methods of nondirective play therapy with other directive approaches
- Describe CCPT based on Guerney's model
- Conduct the 4 primary skills of CCPT
- Handle a wide range of possible situations in play therapy
- Involve parents in meaningful ways in the play therapy process
- Immediately and confidently use CCPT in their work with children
- Discuss the six levels of interpretation and which are appropriate or inappropriate during CCPT sessions
- Describe the phases commonly observed as a child moves through issues in CCPT
- Explain how CCPT can be conducted in conjunction with other forms of play and family therapy

Format includes lectures, live and videotaped demonstrations, case studies and supervision/feedback to participants as they practice during role play. The training is conducted in a playful and lively manner. Participants will start to develop competence as they move along in the training.
