The workshop aims to shift the mindset of social workers and seeks to equip them with the professional values, attitudes, knowledge, and skills needed to design and implement existentially-informed social work interventions and programmes in experiential, reflective, collaborative, and creative ways.


- 1. Application will be accepted on a first-come-first-served basis.
- 2. Email notification on application status will be sent to you only when application and payment have been received by the Division of Continuing Professional Education (CPE).
